The Village East pool is scheduled to open May 26th, Memorial Day weekend. Last year we had issues with a low water level and problems getting the water quality where it needed to be. The pool committee is optimistic that we won't experience such problems this year. The water level is good, and we added a pump to circulate the water twice a day (on a timer) during the winter months. Bob and Mona Richards have graciously offered to continue the daily pool maintenance for the coming season. Last season was going to be their last but circumstances changed. I will be contacting commercial pool maintenance companies to get estimates on what the cost would be if we find we have to go that route in the future. We will be organizing a work party in May to clean and repair tables, chairs and umbrellas and any other task necessary to ensure a safe and effective pool season for Village East POA members and guests. The date has yet to be set and is contingent on the pool cover being removed, tentatively scheduled for 4/30-5/3. The Village East community owes a debt of gratitude to Mark White who undertook the daunting task of rewiring the pool pump house. There were several issues of both a safety and operational concern that have been remedied. In the process, he saved the community several hundred dollars.
